- Find *at least 3 credible sources* that agree
- If you can't, *be suspicious!*

### Mike's Rating System

- \* Needs to be checked out
- \*\* May be ok?
- \*\*\* Credible

\*\*\*\* Very credible

### Family Lore

\* or \*\* Stories passed down

\*\*\* or \*\*\*\* First hand vivid recollections

### Frank Frost's Family

- My mother's first cousin
- Comes from Bucharest, Romania
- Arrived in US around 1900
- Settled mostly in Chicago

### Family Lore: Per Uncle Lew

- My uncle Lew “first cousin Frank worked for **Capone**” \*\*
- Lew's Bar Mitzvah
  - January 1930 (during prohibition)
  - Limousine pulled up and a large box of booze was delivered. \*\*\*
- Cousin Frank showed Lew his car \*\*\*
  - Nice car
  - Glove compartment opened and it was all guns!

### Met Frank's sister Sally and Ira

- Frankie Foster was Frank Frost's professional name \*\*\*
- Sally vividly recalled \*\*\*\*
  - Passing newsstand
  - Headline: “Frankie Foster Indicted for Murder”

- He had to earn big money to support his widowed Mom and 6 younger sisters \*\*
- Was somehow involved in St. Valentine's Day massacre? \*

- Murder probably
  - ordered by Capone
  - Lingle had pocketed \$50,000 for protection of an illegal dog track

## Three Main Questions

- Was the infamous "Frank Foster" really my mother's first cousin Frank Frost?
- Was he involved in St. Valentine's day Massacre on 14 February 1929?
- Was he involved in the murder of Tribune reporter Jake Lingle on 9 June 1930?

## St. Valentine's Day

### Massacre:

14 February 1929

- North Side controlled by Moran
- South Side by Al Capone
- Moran's gang arrived at the garage
- Two men dressed as policemen
  - entered the garage
  - police on a routine investigation?
- Moran diverted to a coffee shop
- 7 Moran men turned backs and were killed in gangland fashion  
It was the "Crime of the Century"

## Murder of Jake Lingle

9 June 1930

- Lingle was reporter for Chicago Tribune
- Was reporter of limited kind
  - Did not write himself
  - Gathered facts
- Murdered on his way to the racetrack
- Tribune posted \$25,000 reward

## Rationale for Killing

- Lived an extravagant lifestyle
- He was a political fixer who bribed police on behalf of Capone

## Documents

- Secondary Sources \* or \*\*
  - Mother's age on birth certificate
  - Background material in newspaper articles
- Primary Sources \*\*\* or \*\*\*\*
  - Date of Birth on birth certificate
  - Facts of yesterday's events in newspapers

## Documents

- FBI files
- Chicago FBI/NARA
- Vault.fbi.gov
- Circuit Court of Cook County
- Chicago Police Department

## Newspapers

- "In the absence of solid information both the police and the press rushed to fill in the gaps with speculation and guesswork"
- After countless retellings magazines, books, and movies now accepted as gospel

## Talked to Librarians

- Deerfield Library (my local library)
  - Does author states his/her sources?
  - Reviewed by NovelistPlus (libraries only), Amazon (editorial reviews)
  - Google the author
- Newberry Library (Chicago)
  - Publisher is University/Academic Press
  - Good footnotes/endnotes/credits
  - What do reviews say
    - ▶ Kirkusreviews.com (web)
    - ▶ Jstor.com (libraries only)

## Book Criteria

1. Does author states his/her sources?
2. Look at author's biography/google author

3. Credible review
4. Academic Publisher

One \* for each of above  
Need 3 or 4 \* to be credible

### **Accuracy of Webpages**

1. Who wrote the page?
2. What is the purpose of the document/why produced?
3. Is this person qualified to write this document?
4. E-mail or a contact address/phone number.

Note: Know the distinction between author and Webmaster.

Give one star for each criteria passed.

### **Was Frank Foster really Frank Frost**

1. Frank's sister Sally's vivid recollection
2. FBI file
3. Family/newspaper photos

### **Involved in St. Valentine's Day Massacre?**

1. Newspaper reports had him dead.
2. Harry Harris remembers
3. Cousin Ira/Arthur Bilek

### **Involved in Lingle murder?**

1. FBI File (cousin Ira)
2. Grand Jury Indictment
3. "Mr. Capone"
4. myalcapone.com

### **But he was good to his mother**

- 14 Feb 1929: St Valentine's Day Massacre
- January 1930: Uncle Lew's Bar Mitzvah
- 9 June 1930: Jake Lingle murder

All family members attest to the fact that he single handedly supported his mother and 6 younger sisters for many years
